Notice of Final Rulemaking January 19, 2018

Arizona Administrative Register, Published by the Arizona Secretary of State | Vol. 24, Issue 3, p. 139

Arizona Administrative Code, Section R2-12-1102. Notary Public Fees

ARTICLE 11. NOTARY PUBLIC BONDS AND FEES

- A. Pursuant to A.R.S. § 38-412, a notary public shall keep posted at all times in a conspicuous location, the fee schedule listed under subsection (E)(1) through (3).
- B. Upon reviewing the fees schedule under subsection (E)(1) through (3), a notary shall select a standard fee, from "no charge" up to the maximum \$10 fee for a notarial act. A notary public shall be consistent when charging fees and post the fee schedule in a conspicuous location.
- C. When posting fees under subsection (A) and (B), notaries shall use the template in Exhibit 1. Notary Public Services.
- D. Before performing any notarial act, the notary public shall inform the requestor of the service fee if one will be charged.
- E. A Notary public may charge the following fees:
- 1. For acknowledgment or jurat, "no charge" up to \$10 per notary public signature;
- 2. For a copy certification "no charge" up to \$10 per page certified;
- 3. For an oath or affirmation without a signature, "no charge" up to \$10 per notarial act.

Legislative Beat

SB 1012

Introduced by Senator Kavanagh
AN ACT amending section 12-3301, Arizona Revised
Statutes; relating to private process servers.

Polit enacted by the Logislature of the State of Arizon

Be it enacted by the Legislature of the State of Arizona: Section 1. Section 12-3301, Arizona Revised Statutes, is amended to read:

12-3301. Private process servers; background investigation; fees A. Private process servers who are duly appointed or certified pursuant to rules established by the supreme court may serve all process, writs, orders, pleadings or papers that are required or permitted by law to be served before, during or independently of a court action, including all such as are required or permitted to be served by a sheriff or constable pursuant to section 11-441, subsection A, paragraphs 6 and 7, section 11-447 and section 11-448, except writs or orders requiring the service officer to sell, deliver or take into the officer's custody persons or property, or as may otherwise be limited by supreme court rule. A private process server is an officer of the court.

- B. IN ATTEMPTING TO SERVE OR WHILE SERVING PROCESS, A DULY APPOINTED OR CERTIFIED PRIVATE PROCESS SERVER IS AUTHORIZED TO:
- ENTER AND REMAIN ON REAL PROPERTY.
- 2. ENTER UNANNOUNCED AND REMAIN IN A PLANNED COMMUNITY OR CONDOMINIUM ASSOCIATION THAT IS GUARDED OR GATED.
- C. As a condition of certification, the supreme court shall require each private process server applicant to furnish a full set of fingerprints to enable a criminal background investigation to be conducted to determine the suitability of the applicant. The completed applicant fingerprint card shall be submitted with the fee prescribed in section 41-1750 to the department of public safety. The applicant shall bear the cost of obtaining the applicant's criminal history record information. The cost may not exceed the actual cost of obtaining the applicant's criminal history record information. Applicant criminal history records checks shall be conducted pursuant to section 41-1750 and Public Law 92-544. The department of public safety may exchange the submitted applicant fingerprint card information with the federal bureau of investigation for a federal criminal records check.
- D. A private process server may charge such fees for services as may be agreed on between the process server and the party engaging the process server.

One of the biggest issues I have experienced through all these years in serving papers is how and when to receive payment from clients (process servers, attorneys, process serving companies). Should I receive payment before accepting the job or should I bill them like some request I do?

Like everyone else in this business, we do require prepayment for most, and on some accounts we will bill them later. I don't know about some of you, but sometimes potential clients will not use my service because I won't bill them and some of the ones that I do decide to bill after the completion of the job don't pay.



My reaction to deadbeat clients is summed up in having billed them as requested, but they still haven't paid me. Hmm... I just don't get it.

After all, I've got to pay my bills, but I wonder, why they are so special that I should work for them for free?

Unfortunately, I had to sue a big process serving company for failing to pay me. I won't mention their name but it should be <u>easy</u> to find in the public access website. I don't like doing it but if you have the biggest contract in two states there is no reason why you can't pay. I blame myself for this as well and boy this won't happen again.

I wish there was some type of way that you can't own a process serving company unless you are a process server. That way, if your process server certification is expired or suspended then you can't operate the business any further.

Well, Luis, this might be a start:

California Business & Professions Code §22350

(a) Any natural person who makes more than 10 services of process within this state during one calendar year, for specific compensation or in expectation of specific compensation, where that compensation is directly attributable to the service of process, shall file and maintain a verified certificate of registration as a process server with the county clerk of the county in which he or she resides or has his or her principal place of business. Any corporation or partnership that derives or expects to derive compensation from service of process within this state shall also file and maintain a verified certificate of registration as a process server with the county clerk of the county in which the corporation or partnership has its principal place of business.

P.S. - I'II give you an "Amen", Luis and say that if the process serving company owner or management are bad apples, then they should be culled from the tree! - Ed.

John explained it was more of including the same language that was already in the other section of law. It was more of a house cleaning for the legislation.



Keeping Up with Cyber Security & Other Issues of Interest

In this year's editions, we're going to cover some of the in's and out's of cyber security, as well as other issues. Many computer users are unaware how vulnerable our data has become. From client information to internal accounting and other documents, as business owners and network users, we all need to be concerned about preventing breeches of data. I reference not only my own experience, but the experience of others.

It boils down to protecting our collective assets — the "7-P Principle".

The American Bar Association (ABA) Journal is undertaking a yearlong series of articles on cyber security. As process servers, all of us are dependent on computers, so I thought it would be a good subject to follow, as well.

I've written and spoken about some of the moronic ways that hackers and scam artists try to get into our computers, but still they keep coming. Advertisements and other emails under the guise of products I may wish to purchase, long lost friends who I never heard of, free gift cards, awards (did you know you can purchase your own "best business in (city)" award?), robocallers and the daily, "Hello, I am calling you from Windows security about your computer" are irritating, to say the least. At times, even the most cynical of us (including yours truly) get fooled by some innocuous looking email, thinking that a friend or client sent it, only to find the attachment on it was a virus-laden pile of numerical garbage designed to put your destiny in someone else's hands.

One wrong click can ruin your day.

There are legislative things happening that affect process servers, as well. Did you know that notarial fees are expected to go up? Yep. Effective March 5th, the Secretary of State has authorized notarial fees to go from "up to" \$2 per signature to "up to" \$10 per signature. That's good if you are a notary and charge by the signature, but may be bad for those of us who need our signatures notarized and are working within a competitive budget.

Our March CLE event will present APSA members and non-members the opportunity to sit for the APSA ACPS class, as well as a class on serving protective orders, report writing and a snippet on skip tracing. It's 10 hours of fun and education at the Aquarius Hotel in Laughlin. The rooms are cheap enough, and for those interested, a board meeting will be held after Saturday's class. The board meeting is open to all and no reservations are required. Stay tuned for more. There's a lot to learn.

WARNING: Bogus Phone Calls, Emails May Lead to Fraud

Superior Court of Arizona in Maricopa County and the Maricopa County Justice Courts has become aware of telephone scams targeting members of the public and threatening them with prosecution for failing to pay court fines or fees.

These calls, which threaten recipients with fines and jail time if they do not provide sensitive information or payment, are fraudulent and are not connected with the Superior Court.

Superior Court and the Justice Courts do not require anyone to provide any sensitive information in a telephone call or email. Most contact from the Court will be through the U.S. mail, and any phone contact by court officials will not include requests for cash, Social Security numbers, credit card numbers, or any other sensitive information. Many customers, especially those in minor traffic cases, do make payments of fines and fees using a credit card and often do so by phone. If contacted by someone saying they are with the Court please call the court/county number back to verify the validity of the call before making any payment. Also, as an option to making payments over the phone please know that many courts offer online payment methods that are safer.

Persons who believe they were a target of a scam should not provide the requested information, and should notify the Attorney General's Consumer Protection Division by filing a complaint through their Website: https://www.azag.gov/complaints/consumer. The Attorney General will provide information to law enforcement for investigation.

We start the New Year with more paper records converted to digital images, a new and faster way to get a marriage license or passport on the horizon, and before you know it, a new Clerk! Happy New Year from the Clerk's office – we are looking forward to serving you throughout 2018.

Juvenile Record Scanning Complete

In December, the Clerk's office completed its Juvenile Back-Scanning Project. The project, which began in November 2016, was conducted to convert paper juvenile files from inactive cases in all juvenile case types into scanned images. During the yearlong effort, Clerk staff prepared and scanned more than 10 million pages (more than 3 million documents). After scanning and quality control audits, the office disposed of the paper documents, resulting in significant storage savings.

February 2018

Clerk's office carries on

Clerk of the Court Michael Jeanes retired on Monday, February 5. To ensure continuation of services in the office, Presiding Judge Janet Barton signed a local administrative order naming the Clerk's Chief Deputy, Chris Kelly as interim Clerk, pending the governor's appointment of a Clerk. Chris Kelly has been the office's Chief Deputy for 12 years and she will return to those duties exclusively when the governor appoints a new Clerk from among the candidates who applied. eCertification expands in February

On February 1, the Clerk's Office expanded its process of providing electronically certified copies of certain court documents. Applying an electronic certification to an electronic or paper document is a change from the traditional format of manually applying a raised certification seal onto paper.

Marriage license and passport appointments – plus Saturday hours

The Clerk's office now accepts online appointments for issuing marriage licenses and processing passport applications at regional locations via the Clerk's website.
